- 6. Electronic bids must be submittedthrough PPMO's e-GP system <u>www.bolpatra.gov.np/egp</u>on or before12 hours on2077/10/30. Bids received after this deadline will be rejected.
- 7. The technical bidswill be opened in the presence of Bidders' representatives who choose to attend at 13.00 hourson 2077/10/30 at the office ofBarahakshetra Municipality chakraghatti ,sunsari. Bids must be valid for a period of 90 daysand must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid. Bid security which shall be valid for 30 days beyond the validity period of the bid . Bidders may deposit bid security amount in cash on deposit account number 0220010117404 of mega bank chakraghatti branch in the name of Barahakshetra Municipality Chakraghatti , Sunsari or bank/ financial institute guarantee.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Bidders may submit modification of withdrawal prior to the deadline prescribed for submission of bid through e-GP system by using the forms and instructions provided by the system. Once a bid is withdrawn, bidder will not be able to submit another bid response for the same bid.
- 10. After the completion of evaluation of Technical bids which are substantially responsive evaluated bidders, will be invited to attend the opening of Price Bids. The date, time and location of opening of Price bid shall be notified in writing and/or published in national daily.
- 11. Other mandatory information will be as per Public Procurement Act 2063 and (PPA) and Public Procurement Regulation 2064(Amended).
